Between 2019 and 2024, in CPK sp. z o.o. she participated in the development of the Airport Subprogramme by preparing projects and planning documents related to the planning and design phase of the future airport.

She has served on the Supervisory Boards of, among others, railway and airport companies – PPM-T sp. z o.o., Dolkom sp. z o.o. and Port Lotniczy Wrocław S.A.

She has been involved in a number of projects for the development of feasibility studies, financial models, business analyses and evaluation studies for infrastructure projects. She worked with the Warsaw School of Economics engaging in scientific and educational activities.

She obtained her MBA from the Warsaw University of Technology as part of a programme in collaboration with London Business School, HEC School of Management and NHH Norwegian School of Economics.
