Net contract value: 691,444,047.41 PLN (in words: six hundred and ninety-one million, four hundred and forty-four thousand, and forty seven 41/100 PLN).

Gross contract value: 843,561,725.64 PLN (in words: eight hundred and forty-three million, five hundred and sixty-one thousand, seven hundred and twenty-five 64/100 PLN).

Participation of Polimex–Mostostal S.A. in the works and remuneration shall constitute: 49 % of the whole.

Realisation period: 32 months of the commencement date.

Period of warranty for defects: 3 years.
